USD & ZAR ACCOUNTS

The Introducing Broker earns Referral Fees when the **Traders referred by him trade and the trades are closed**. These Traders are charged "Spreads" when they trade. The Introducing Broker receives a referral fee equal to the fixed amount per lot size traded as set out below.

EXCLUSIONS

QuickTrade.World does NOT pay any Referral fees to an Introducing Broker when their Traders trade with a "Commission Account". Referral fees are only paid when Traders trade with a "Spread Account".

NO Referral Fees are paid on trades closed by Traders who trade in the following groups:

1. Micro Indices Group
2. Commission Accounts

EXPLANATIONS

THE IB RANKING SYSTEM EXPLAINED:

An Introducing Broker uses the Introducing Broker URL (link) created by **QuickTrade.World** to refer clients to **QuickTrade.World**. An Introducing Broker gets paid a referral fee when traders they referred to **QuickTrade.World** close their trades.

When an Introducing Broker starts with **QuickTrade.World**, he has zero referred traders with zero lots traded. This Introducing Broker starts with the rank of a **GOLD** Introducing Broker on the IB Ranking system.

QuickTrade.World assigns the USD 3 Per Lot IB campaign to this new Introducing Broker, which is the lowest referral fee that is paid to Introducing Brokers who refer traders to **QuickTrade.World**. For an Introducing Broker to be promoted to a higher rank, the qualifying criteria for Total Lots Traded must be met in a calendar month.

For example, an Introducing Broker whose existing referred traders trade more than 150 Lots in the same calendar month will be promoted to the rank of an **EMERALD** Introducing Broker for the next calendar month.

QuickTrade.World will adjust the IB campaign for this Introducing Broker and pay a referral fee of USD 4 Per Lot on trades closed by his referred traders for the calendar month following the month the qualifying criteria (+ 150 Lots Traded) were attained.

This promotion is for the next calendar month **ONLY**. The Introducing Broker must meet the same qualifying criteria to stay at the achieved rank for future months.

If the total number of lots traded by the traders referred by the Introducing Broker increases, the Introducing Broker will be promoted to a higher rank and **QuickTrade.World** will adjust the IB campaign for this Introducing Broker and pay the corresponding referral fee for the calendar month following the month in which the qualifying criteria were attained.

For example, an Introducing Broker whose existing referred traders trade more than 450 Lots in the same calendar month will be promoted to the rank of a **RUBY** Introducing Broker. **QuickTrade.World** will adjust the IB campaign for this Introducing Broker and pay a referral fee of USD 6 Per Lot for trades closed by the traders referred by the Introducing Broker for the calendar month following the month the qualifying criteria (+ 450 Lots Traded) was attained.

This promotion is for the next calendar month **ONLY**. The Introducing Broker must meet the same qualifying criteria to stay at the achieved rank for future months.

All Introducing Brokers who don't meet the qualifying criteria in a calendar month to stay on a specific rank or meet the qualifying criteria to be promoted will be downgraded to the rank (for the next calendar month), which corresponds to the number of Lots traded (by the clients they referred) in that specific month.

For example, an Introducing Broker who achieved the rank of **DIAMOND** and who has less than 150 Lots Traded by their referred traders during the month in which they receive the referral fees paid to a **DIAMOND** Introducing Broker will be downgraded to the rank of a **GOLD** Introducing Broker for the next calendar month. This means their IB campaign will be adjusted from USD 7 Per Lot to USD 3 Per Lot for the next calendar month.

It is essential to understand that Introducing Brokers are promoted and demoted monthly according to the number of lots traded by the clients they refer.

DEFINITIONS

“Referral Fees” The Introducing Broker earns Referral Fees when their traders trade and the trades are closed. These Traders are charged “Spreads” when they trade. The Introducing Broker receives a referral fee equal to the fixed amount per lot size traded as set out below. Capitalised terms used below have the same meaning given to those terms as in the Agreement.

“Spreads” means the spread charged to Traders, when they trade, which is then used to determine the income due to QT. The Introducing Brokers Referral Fee is calculated as a fixed amount per Lot, as set out in the Ranking System Table to Annexure A above; and,

“Lot” means the quantity of the underlying reference instrument comprising the contract size traded by your Traders.

“Monthly Lots Traded” means the number of Lots traded in a calendar month by the Traders who the Introducing Broker referred to QuickTrade.World.

“Monthly Money/Lot Referral Fee” means the referral fee QuickTrade.World pays to the Introducing Broker in the month following the month in which the Introducing Broker meet the specific rank.

“Rank” means the monthly money per lot referral fee amount the Introducing Broker qualified for by their performance in the previous calendar month. The Introducing Broker will be paid this referral fee for lots traded in the month following this qualification.
